The letter should be addressed to The Consulate of Angola, {JURISDICTION} and should give the following details:

- Relationship to the applicant.
- Dates and duration of the visit.
- Exact address of stay and contact phone number.

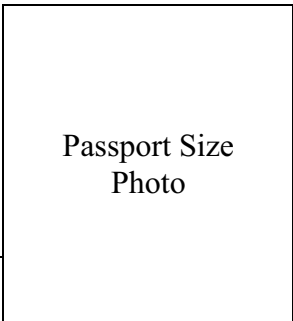
